Welcome to our Annual Report as a 501(c)3 nonprofit public charity! We provide educational services, such as ULA Education. ULA Education is an online vocational school for low-income high school graduates seeking jobs and to attend college. We currently have 199 openings for students to learn from customized programs. Yet, we seek to fundraise to utilize our offerings to the masses in Arizona, followed by California, growing thereafter into a university.

What is Global Human Rights Charity's mission?

"The nonprofit's mission is to create and establish an educational institution, known as University of Latin America. We seek donors for fundraising purposes to build curriculum for certificate, bachelors, masters and doctorate online degree programs."

QQ: What did Global Human Rights Charity accomplish in 2023|2024?

A: Global Human Rights Charity had setbacks in 2023|2024 within administration/governance, accounting/finance, engineering/IT, HR/legal, and sales/marketing.

### History of GHRC

On 02/03/22, IRS determined Global Human Rights Charity as "exempt from federal income tax under Internal Revenue Code (IRC) Section 501(c)(3). Donors can deduct contributions they make to you under IRC Section 170. You're also qualified to receive tax deductible bequests, devises, transfers or gifts under Section 2055, 2106, or 2522 [...]

Organizations exempt under IRC Section 501(c)(3) are further classified as either public charities or private foundations. We determined you're a public charity under the IRC Section [170(b)(1)(A)(vi)]" effective date as October 27, 2021.

### Administration/Governance

The chairman and president, Ricardo Soto, has a disability that effects his work performance. Ricardo has retained three law firms on contingency basis, which are all pending issues. Ricardo is currently seeking a law firm specializing in government surveillance on a contingency basis.

## Accounting/Finance

Ricardo was the sole contributor to Global Human Rights Charity, while working at another employer. Due to issues described in Management and Leadership this option is no longer available, currently. Therefore, no donations, nor monetary grants have been contributed to Global Human Rights Charity. Yet, on 01/20/23, Global Human Rights Charity signed a two-year agreement with CrowdStrike valued at \$7133.50 offered at 100% discount at \$0 cost within their Pro Bono Cybersecurity Program.

## Engineering/IT

Our main weakness is the area of cybersecurity, which does not stand a chance against government cyberwarfare. The ability to perform research, work, and fundraise is our human right. It is those who have access to the internet backbone, such as the military/intelligence community that is disrupting the global economy.
